



**Destin Area Chamber of Commerce  
32nd Annual Destin Seafood Festival  
Application for Artwork**

***Theme: The Heart of the Harbor***



I, the undersigned, understand that if my submitted design and original artwork is selected, then I will fulfill all obligations for the Destin Seafood Festival Committee listed below:

1. Art must display "32nd Annual Destin Seafood Festival" and the year (2010). *\*\* It is recommended that the name "32nd Annual Destin Seafood Festival" and the year be added separately (added after selection) so art can be used if not selected.*
2. As winner, I am required to produce a minimum of 250 printed posters, and, in return, I will be given a complimentary booth space and tent at the Seafood Festival to sell posters.
3. A percentage (20%) of the net profit from the sale of my selected poster will be donated to the Destin Area Chamber of Commerce. (Net profit includes any profit made after costs have been deducted.)
4. As winner, I am required to provide the Destin Area Chamber of Commerce with the first signed, matted, and framed print along with 25 signed and numbered prints to be given to the sponsors of the festival.
5. The Destin Area Chamber of Commerce retains rights to reproduce the art on t-shirts, for use and sale by the Charter Boat Association. The Seafood Festival logo will appear on the front of the shirt with the art imprinted on the back.
6. The art must reflect this year's chosen contest theme, 'The Heart of the Harbor.'

I, the undersigned, understand that if my submitted design and original artwork is not selected, then my artwork may not be reproduced for sale or otherwise with words that may cause one to believe that the artwork represents the official Destin Seafood Festival poster.

- Artwork that is in violation includes, but is not limited to, artwork that references the following words in any combined order: *Destin, Seafood, Festival, official, art, poster, or the current year (2010).*
  - Any artwork displaying these words cannot be displayed and/or sold without request/review/consent by the Destin Area Chamber of Commerce.
- ⇒ I fully understand and acknowledge that the Destin Area Chamber of Commerce is vested with the sole authority and discretion to determine whether a violation of this agreement has occurred.
- ⇒ I understand that if I am found to be in violation, the Destin Area Chamber of Commerce, in its sole and absolute discretion, may either prohibit sale of the offending artwork or close my booth and terminate my participation in the Destin Seafood Festival.
- ⇒ I hereby waive any and all rights to any damages arising out of or in any way related to the prohibition of the sale of any artwork or the termination of my participation in the Destin Seafood Festival pursuant to this agreement.
- ⇒ I give the Destin Area Chamber of Commerce and the Destin Seafood Festival unconditional use of my artwork, if it is selected as the official poster for the 32nd Annual Destin Seafood Festival.

The Destin Area Chamber of Commerce and the Festival Committee, as official promoters and organizers of the Destin Seafood Festival, retain the sole propriety over all aspects of the festival, which include official poster, official t-shirt, admission, and vendor selections.

All monies raised by the Destin Seafood Festival fund membership programs for the Destin Area Chamber of Commerce annually. Your participation and cooperation is greatly appreciated. Applications are due to the Chamber by 11a.m. on Monday, May 17. The winner will be notified by June 14. The festival dates are Sept. 17-19, 2010.
